#### **Facilities**

- Crawfish Aquatics, 107 Susan Street, Lafayette, LA 70506
- Outdoor, heated, 8 lane 25-yard pool. Non-Turbulent lane ropes with lane width eight feet; pool depth 6 feet (starts end) to four feet (shallow end).
- An indoor, four lane 25 meter pool is available for warm-up/warm-down throughout the meet.
- Daktronics Timing System with electronic 8 line scoreboard.

#### **Rules and Eligibility**

- Swimmer's age as of March 30, 2019 determines age for the meet.
- All ages allowed! Including Masters, parents, coaches, even a friend you want to challenge in your sport.
- Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, or locker rooms.
- A waiver will be required for each participant.
- An "in water starting position" will be permitted.

#### **Entries**

- Each swimmer may enter a maximum of 5 events.
- A hytek team manager file will be submitted by participating teams.

#### **Entry Deadline**

- All meet entries are due by Friday, March 22.
- Deck entries will be accepted at the discretion of the Meet Director and the fee is double and payable at time of entry. This includes ANY changes from one event to another during the meet.

#### **Entry Fees**

**Conduct**

- NT entries will not be accepted for stroke races.  
*\*Please create an estimated time (divide their best 50 time by 2 or best 100 time by 4)*
- NT acceptable for underwater race
- All timed final events will be swum slowest to fastest.

**Scoring and Awards**

- Award will be given to each event champion
- Events will be ranked as female/male and age groups 8 & U, 9-10, 11-12 year old, 13-14, 15 & Older.

**Timing Assignments**

- Timers will be provided by Crawfish Aquatics
- Timers will report 10 minutes prior to the start of each session.

**Warm-up & Procedures**

Lane assignments to be announced prior to the start of warm-up.

**Deck Changing:**

Changing into or out of swimsuits other than in locker rooms or other designated areas is not permitted.
