Rules

Conduct if this event shall conform in every respect to all technical and administrative rules of USA Swimming and Louisiana Swimming. Any swimmer entered in the meet must be accompanied by a Certified USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. accompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.- All meet directors, referees, starters, and stroke and turn judges, serving in an official capacity must be members of USA Swimming. All coaches and officials constantly display their current USA Swimming credential or be prepared to present their USA Swimming ID card as proof of their registration to the Meet Director designee at any time. The meet referee reserves the right to ask for coach credential display and/or deny

deck access if coach does not comply or card is no longer valid / current. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, or locker rooms. Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is strongly discouraged. It is understood and agreed that USA Swimming and Louisiana Swimming, Inc. shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.

Entry Limits. The meet will be limited to the number of swimmers entered. No swimmer will be permitted to compete unless he/she is a member of USA Swimming as provided in Article 302.

Conduct of meet: All events will be timed finals.

Entry limit: This meet will be managed to stay within the Louisiana time limit of four hours. If entries become too large, coaches will be notified if their entry is rejected. Each swimmer will be limited to (4) individual.

Entry fees: Individual events will be \$3.50 each. The Louisiana surcharge is \$7.00 per swimmers. There will be a facility fee of 7.00 which will include a heat sheet. Late entries will be accepted up to 30 minutes prior to the start of each session. No new heats will be added.

Timers: Each team entering this meet will be required to supply timers.

Warm-up: USAS rules & regulations require all warm-ups to be closely supervised by an USAS registered coach or official. A six lane outdoor pool will be available for warm up & cool down during the meet.

Facility rules: St. Martin's Episcopal School, ask that all swimmers & spectators comply with the following facility regulations.
